The Company had, pursuant to the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, appointed Mr. Adesh Kumar Agarwal, as Additional in Independent Category on Board Meeting held on 4<sup>th</sup> December, 2018 in compliance with the requirements of the provisions of section 149 of the Act and other applicable laws.

Mr. Adesh Kumar Agarwal, non-executive directors of the Company, has given a declaration to the Board that they meet the criteria of independence as provided under section 149(6) of the Act. In the opinion of the Board, each of these directors fulfill the conditions specified in the Act and the Rules framed thereunder for appointment as Independent Director and they are independent of the management.

In compliance with the provisions of section 149 read with Schedule IV of the Act, the appointment of these directors as Independent Directors is now being placed before the Members for their approval.

### ITEM NO. 4

The income has derived income from the trading of shares and securities as per the financials of the company ended on 31<sup>st</sup> March, 2018. Accordingly, Board decided to include this activity as main activity of the company.
