

Hint of go-slow on on-line retail rules

New Delhi: The government is exploring the possibility of deferring the new FDI norms in e-commerce even as Walmart-backed Flipkart has warned of 'significant customer disruption' if the norms are not delayed by six months.

The norms notified last month prohibit large online marketplaces such as Amazon and Flipkart from owning equity in any of their vendors or having control over the inventory sold on their platforms.

been affected by demonetisation and the past year's back-door entry of online retailers with deep pockets. However, sources said the government could postpone the norms by a couple of months to enable the global players to restructure their businesses.

The guidelines said e-commerce entities, which operate a marketplace, will not be allowed to exercise ownership or control over inventory. Any ownership or control over the inventory

will convert the business into an inventory-based model. While Amazon has sought a deferral by four months, Flipkart is said to have proposed a six-month extension in their letters to the Department of Industrial Policy and Promotion (DIPP).

They have reportedly told the DIPP that it would be difficult for them to comply with the rules by February 1 as it involves extensive overhauling of its business model and systems.

The policy move has jolted the market, which last year invested \$16 billion in Flipkart in its biggest ever deal, and Amazon, which has committed \$5.5 billion in India investments.

Industry sources have said the new policy will raise compliance costs and force Amazon and Flipkart to review their business arrangements in the country.

Global firms' concerns were evoked by the US government with Indian officials through various socio-economic measures and pro-people initiatives, said the Governor.

EC has supervised free and fair elections for 7 decades: Pranab Mukherjee

New Delhi: At a time when the Opposition has raised questions on the autonomy of the Election Commission, former President Pranab Mukherjee has described the EC as a "truly unique body" that has supervised "free and fair" polls for the past seven decades.

Mukherjee, who was recently awarded India's highest civilian honour Bharat Ratna, says in the foreword to 'The Great March of Democracy' edited by the 17th Chief Election Commission S.P. Uteshi, that democracy is not a gift to India, "but a sacred trust".

The 83-year-old Congress leader has also constructed 'Indian nationalism is constitutional patriotism', highlighting that of several factors that compel it, one is "the ability to self correct and learn from others".

He states that when independent India made universal adult suffrage the basis of elections, not all were convinced of its implementation.

"However, the successful manner in which the very first elections were conducted put these speculations to rest. Since then, over the years, the EC has been conducting free and fair elections, successfully and improving on deficiencies in increasing participation in elections," he says.

He also expresses his worry on the abuse of money and muscle power to influence voters during the elections.

"The spirit of democracy will be subverted if these malpractices are not checked. It is commendable that the Election Commission has taken up initiatives to promote ethical and informed voting," notes Mukherjee.

He further counts the "invaluable contributions" by poll panel officials in efficiently managing elections, improving voter registration, enhancing voter participation, educating and motivating voters, fighting black money, influence of money power and paid news during elections, and ensuring a conducive environment for people to cast their vote.

Mukherjee ends his four-page prologue to the book, published by Penguin, by reminding readers that "the soul of India resides in pluralism and tolerance."

Nissan abandons plans of X-Trail model in UK

London: Japanese carmaker Nissan confirmed it had abandoned plans to build the new model X-Trail in Sunderland, UK, Sky News reported on Sunday.

According to a letter written by Nissan Europe chairman Gianluca Ficcy to workers, the X-Trail will continue to be made in Japan.

Ficcy said Brexit uncertainty had played a part in the decision, added that "We have taken this decision for the business reasons I've explained, but clearly the uncertainty around Brexit and the relationship with the EU is not helping companies like ours to plan for the future."

According to the letter, "The UK's departure from the EU on March 29th getting closer every week, we have a taskforce in place, reporting to me, that it is considering all of the possible scenarios and the potential impact on business," he said, reports Xinhua.

Sunderland will continue to benefit from the investment planned for Luke and Oshagh. Nissan announced around 7,000 people in Sunderland. The X-Trail production plans had been announced in the autumn of 2016.
